This Addendum is made as of the date referenced below and hereby supplements and amends the Candidate Information Form to which it is attached. Defined terms in this Addendum shall have the meanings ascribed to them in the Candidate Information Form unless otherwise set forth herein. Club and Member agree and acknowledge that Member qualifies for the Club's Young Executive Membership category and applicable classification, subject to the terms and conditions stated herein.

1. Young Executive Memberships; Term. Young Executive Memberships are offered by the Club, from time to time, to individuals under the age of forty (40). (Twenty-One (21) to Thirty-Nine (39)).

Young Executives under 40 Young Executive Memberships are offered by the Club, from time to time, to individuals under the age of forty (40). As an Under 40 Member, Member, and Member's spouse and qualified dependents (as defined by the Club's Membership Bylaws) if such Under 40 Membership is a family membership, may enjoy all of the privileges of membership afforded by the Club for the applicable classification of membership, for a reduced dues amount until the fortieth (40th) birthday of the Member or the fortieth (40th) of Member's spouse, whichever occurs first (the "Under 40 Conversion Date"), after which time Member must begin paying the full monthly dues rate for an available membership category and classification.

To continue being a Member of the Club after the Under 40 Conversion Date, Member must convert from the Under 40 Young Executive Membership category and classification and corresponding reduced dues amount to an available membership category and classification.
